- c) At present the above said trust not own any movable/immovable assets apart from the corpus amount of Rupees.5000/-

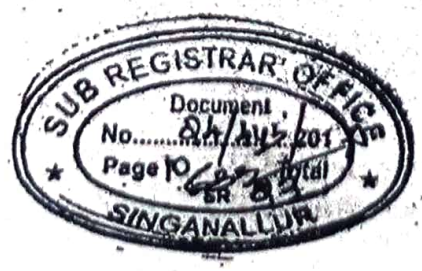
